1. АННОТАЦИЯ ДИСЦИПЛИНЫ

Microeconomics considers the behavior of decision-makers within the economy, such as individuals, households, and firms. These behaviors are crucial building blocks of economy to even understand "macro level" (country or global level) issues; as a result, modern macroeconomics is also micro-founded. Thus, microeconomics is the main tool to understand all aspects of economy, whether it's at the micro level (decisions of consumers and firms) or macro level (decisions of central banks and governments).

Topics include social choice and welfare, market economy, imperfect competition, imperfect information, communication, and informal markets (social networks).

To explore these topics, students will engage in activities (inside and outside the classroom) to ensure an understanding of the course topics and the applications of such concepts.

This course will help students to "think like an economist": they will learn to formulate and analyze models that can provide useful predictions about the economy (and society in general).

This is a comprehensive course and it will cover most concepts and ideas related to economics. Following is a "partial list" of concepts that will be covered in this course: consumer behavior, competitive markets and general equilibrium, welfare analysis (efficiency, equity, deadweight loss), monopoly and market power, oligopoly, game theory (Nash equilibrium, sequential games, repeated games, etc), asymmetric information, and externalities.

4. ОЦЕНОЧНЫЕ СРЕДСТВА И ПРИМЕРЫ ЗАДАНИЙ ДЛЯ ОЦЕНКИ РЕЗУЛЬТАТОВ ОСВОЕНИЯ ДИСЦИПЛИНЫ

4.1 Текущий контроль

During the course students work individually and in groups.

- Group work: On the first day of class, I will divide students into groups. At the end of each class, I will assign each group a task to complete. On the next class, one member will be randomly selected from each group to present their group task.
- Individual work: Each student will be asked to develop an original model about some economic phenomenon and provide valuable predictions about them. At the end of the course, each student will be asked to present their model and results to the class.

4.2 Промежуточная аттестация

The examination will consist of a 90-minute written test that includes the identification of ten quotations from required course readings and a written essay. The use of any electronic

devices is prohibited. The student must: 1) Attribute the given quotations; identify the sections of the texts (such as a chapter) where the quotations are taken from as well as their authors, titles, and year of publication. 2) Based on the given quotations, write an essay in English (1000 words) analysing semantic relationships between the texts where these quotations are taken from.

4.3 Примеры заданий

Quotes examples:

- (1) "In the standard model of collusion, symmetric firms interact in an infinitely repeated Bertrand game in which past prices are publicly observed. The standard model offers a number of insights, but it presumes an unchanging market environment. This is an important limitation, since the scope for testing a theory of collusion is greater when the theory offers predictions concerning the manner in which collusive prices vary with underlying market conditions."
- (2) "Orthodox economic theory has little to offer in terms of understanding how nonmarket organizations, like firms, form and function. This is so because traditional theory pays little or no attention to the role of information, which evidently lies at the heart of organizations."
- (3) "Many of the difficulties associated with reaching agreements are informational. Bargainers typically have different information about preferences and even about what is feasible. Sharing information makes available better potential agreements, but it also has strategic effects that make one suspect that revealing all to an opponent is not usually the most advantageous policy."
